Objectives and Investment Policy

Templeton China Fund (the "Fund") is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

· equity securities issued by companies of any size located in, or doing significant business in, China, Hong Kong and Taiwan

Significant busiless in, China, Hong Kong Kong Stock Connect, Shenzhen-Hong Kong Stock Connect, through qualified foreign investor (QFI) portfolios, UCIs and any permissible means available to the Fund under prevailing laws and regulations) and up to 20% of its net assets in China B-or context of the function of Shares

The Fund can invest to a lesser extent in: • equity securities for which the principal markets for trading are China, Hong Kong and Taiwan, or whose performance relates to assets in, or currencies of, those countries

· equity or debt securities issued by companies of any size located in any country, including other emerging markets

· derivatives for hedging and efficient portfolio management

Why is the Fund in this specific category?

The Fund invests mainly in Chinese equity securities. Such securities have historically been subject to significant price movements, frequently to a greater extent than equity markets globally. As a result, the performance of the Fund can fluctuate very significantly over relatively short time periods.

The benchmark of the Fund is the MSCI China 10/40 Index-NR - Linked. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Terms to Understand
