What is this product?

This product is a sub-fund of the fund BL constituted in the form of an investment company with variable capital with multiple sub-funds under Luxembourg law, subject to Part I of the Luxembourg law of December 17, 2010 concerning undertakings for collective investment.

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

Seeking a long-term capital gain.

The sub-fund invests a minimum of 75% of its net assets in shares of companies listed on a European regulated market.

A maximum of 10% of the net assets may be invested in open-ended investment funds.

The sub-fund may also use derivative products for hedging purposes or in order to optimise the portfolio's exposure. The companies are chosen on the basis of their intrinsic quality and their valu-

ation and will be subject to corporation tax under the conditions of ordinary law or to an equivalent tax.

The investment manager integrates and promotes sustainability factors within his investment strategy by applying non-financial data to the issuer valuation model.

In addition, the investment manager incorporates ESG criteria through a selectivity approach, which consists of reducing the investment universe by 20% by excluding issuers with a lower non-financial rating.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is aimed at investors who are looking for earnings and capital growth over a long time period. The investor may experience losses up to the amount invested. This product is suited to investors with a basic to in-depth knowledge and experience of the product and the global equity markets.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.
