Objectives and Investment Policy

Templeton Global Smaller Companies Fund (the "Fund") aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests

 equity securities issued by smaller companies (i.e. with a market capitalisation within the range of the market capitalisations of companies included in the MSCI All Country World Small Cap Index), located in any country, including emerging markets

The Fund can invest to a lesser extent in:

- equity securities issued by companies of any size located in any country
 derivatives for hedging and efficient portfolio management

The investment team uses in-depth analysis to select individual equity securities that it believes are undervalued and will provide the best opportunities for increased value over the long term

The benchmark of the Fund is the MSCI AC World Small Cap Index-NR. The Fund uses a benchmark index to define small caps as the range of

acceptable market caps at initial purchase and also as a reference for Investors to compare against the Funds' performance. The Fund is not obliged to hold any of the benchmark constituents and may indeed invest up to 100% of its net assets outside the benchmark.

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Why is the Fund in this specific category?

The Fund invests mainly in equity securities of smaller companies around the world. Such securities have historically been subject to significant price movements that may occur suddenly due to market or company-specific factors. As a result, the performance of the Fund can fluctuate significantly over relatively short time periods.

Risks materially relevant not adequately captured by the indicator:


